- use optimization methods in solving logistics chains;
- understand the new trends of combined transport and their usage.

The graduate is employed in the positions of technical-administrative personnel in the operation, management and business-economic activities in specific types of transport and in the professions within the whole transport system. Graduates gained prerequisites to find employment in the management of transport infrastructure in the Czech Republic and EU. Examples of possible jobs: independent technician, operation manager or specialist of road, railway, air, public and inland waterway transport, logistician in transportation and shipping, forwarding agent.
